### **Official Contest Rules**

#### **1. Contest host and organizer**

The host of the Contest Vanity Club, s.r.o. with its registered office at Příkop 843/4, Zábrdovice (Brno-střed), 602 00 Brno, Czech Republic, Company ID number 05768012, registered in the Commercial Register managed by the Regional Court in Brno, section C, file number 97921 (hereinafter referred to as the “**Host**”).

The Contest organizer, ensuring practical steps during its holding, is MUSTARD s.r.o., a limited liability company with its registered office at Masarykovo nábřeží 246/12, 11000 Praha 1, Czech Republic, Company ID number 28531418, registered in the Commercial Register managed by the Metropolitan Court in Prague, section C, file number 148383. (hereinafter referred to as the “**Organizer**”).

#### **2. Contest term and place**

The Contest will be held from **18. 10. 2019 to 31. 10. 2019** on The Illusionists Tour Facebook @theillusioniststour and Instagram @the\_illusionists\_tour accounts (hereinafter referred to as the “**Contest**”). The communication with participants is primarily conducted via **Facebook and Instagram comments below the Contest post and thereafter in private messages**.

#### **3. Contest participants**

The Contest may be entered by any individual who has reached at least 18 years of age, regardless of the country in which he/she resides.

To enter the Contest, it is necessary to answer the Contest question via comment below the Contest picture on Facebook or Instagram. The post will be published on the 17. 10. 2019 on The Illusionists Tour Facebook (<https://www.facebook.com/theillusioniststour/>) and Instagram page ([https://www.instagram.com/the\\_illusionists\\_tour/](https://www.instagram.com/the_illusionists_tour/)).

The total number of 3 participants will be drawn by the jury. The winners will be contacted via Facebook and Instagram personal messages. If the winner doesn't react, even to a message sent repeatedly by the Organizer within three days, his/her prize will expire without any compensation and will be passed onto the next correct answer that will be positioned in third place under the original winning comment.

All persons who have participated in the preparation of this Contest, mainly persons employed by or in a similar relationship with the Host or the Organizer, are ineligible to participate in the Contest, as are any persons in a similar relationship with the participating authorized The Illusionists Tour partner or with agencies entrusted with operating this Contest, their family members, and persons close to them.

Participation in the Contest does not require purchase of any product or pay an entry fee.

#### **4. Contest mechanism, evaluation of winners**

The task of the Contest participant is to **answer the Contest question via comment below the Contest post on Facebook or Instagram**.

If the winner doesn't react, even to a message sent repeatedly by the Organizer within three days, his/her prize will expire without any compensation and will be passed onto the next participant with correct answer.
